Breakdown of licenses and exams

Each level has associated privileges allowing you access to parts of the spectrum, power levels, and so on. Every third year, the exam pool for each level and the exam sets will be updated or changed. About 10% of the question pool changes. This means that published materials will expire..

Technician & General

The exam pool consists of 400 questions and answers for both levels, which are published. You will receive a set of 35 questions and a passing score is 26.

As a Technician you will have access to approximately 75% of the frequency spectrum, covering a few slices of HF, but mostly 50MHz and higher.

As a General, you will have access to a majority of the spectrum at about 93%. You will also have the privilege of being allowed to be a volunteer examiner for anyone taking the Technician exams. At this level, the world is your oyster.

Amateur Extra

The exam pool consists of 600 questions and answers, also published. You will receive a set of 50 questions and a passing score is 35.

As an Amateur Extra, you will have full access to the entire spectrum assigned to Amateur Radio Operators. Another privilege is that your are authorized to be a volunteer examiner for ALL amateur license levels.

On or before the day and time of the exam

You MUST go to the FCC Universal Licensing System website and sign up for your FCC Registration Number (FRN). This is **REQUIRED** on the paperwork you will fill out before being given a test.

Questions & Answers

So you want to get your Amateur Radio License, do you have what it takes? YES!

Do I have to go to the FCC office to take a test?

No, as an amateur radio association, we are authorized by the FCC under agreement with the LAUREL VEC to administer all of the amateur radio examinations. We have a pool of General and Amateur Extra volunteer examiners that are more than happy to show up to be there to administer exams. Please do us the honor of allowing us to serve you in this capacity.

What are the costs to get a license?

MARA does not charge to administer exams.

After you pass the Technician exam, as of April 2022, the FCC charges a \$35 fee for your first 10 years and subsequent 10 year intervals. They will email you at the address you provided in the FCC ULS with the details on how to make payment. Once you pay the fee, you will receive your license with a link to download a PDF copy that you can then print out.

Subsequent upgrades to General or Amateur Extra do not incur any fees at this time.
